Anderson to allow town pier to be put in and removed by Reilly's Pub on the town access, as well as placing a sign stating public access and a flag on the pier. All ayes. None opposed. Motion carried.

Kristine Court Right of Way – Weckwerth explains what needs to be done with title work. A title search was completed and paid for by the town. This will be tabled and placed on next month's agenda.

Summer Roadwork Repair Projects – Otto Road needs to be sealcoated. Nelson Rd., Old Green Lake Rd., Roeder Rd., Losinski Rd. and Oak Tree Acres problems are discussed. Motion Allan Weckwerth/Dan Kuglin to hire county to chip seal Otto Rd. in Summer of 2024. Gary Anderson abstained. None opposed. Motion carried.
