Motion Dan Kuglin/Gary Anderson to approve agenda. All ayes. None opposed. Motion carried. Motion Dan Kuglin/Gary Anderson to approve minutes of the November 13, 2024 meeting minutes as published. All ayes. None opposed. Motion carried.

Treasurer's Report – Treasurer Wagner reads report. Motion Dan Kuglin/Gary Anderson to submit treasurer's report for audit. All ayes. None opposed. Motion carried.

Maintenance Supervisor Report – Rear blade was repaired on tractor. General Engineering started stormwater study on Lakeshore Dr. Truck had to go out for two small snowfalls. Fire extinguishers were inspected. The alternator has been replaced on the International. Land Conservation has been contacted to develop a plan to fix water problems in town hall parking lot.

Payment of Claims – Invoice was submitted by Kuglin Contractors for \$10,500. The original bid was for \$6,500. Reason for higher bid is because ramp was made wider, per request to comply with ADA guidelines. Therefore, the weight dynamics were changed when the two feet were added. The railings are powder coated which also increased the price. Motion by Gary Anderson/Allan Weckwerth to pay Kuglin Contractors for finished project at \$10,500. Recycling contract bids -- Town's recycling contract with GFL will be ending on March 15, 2025. Waste Management did not provide a quote. Supervisor Kuglin reads quote that GFL provided for a three year contract for a monthly total of \$927.54. Chairman Weckwerth reads quote that Waskovick, Inc. provided for a three year contract with a monthly total of \$670.00 for the first year, with slight yearly increase for year two and year three. Motion Dan Kuglin/Gary Anderson to award three year recycling contract to Washkovick, Inc. All ayes. None opposed. Motion carried.

Replace furnace in town hall – New furnace will be purchased from Superheat, Inc. The current furnace is no longer able to be repaired.
