***MINUTES**

January 14, 2026

Regular monthly meeting of the Board of Supervisors, Town of Princeton, called to order by Chairman Weckwerth. Open meeting law requirement met through posting and publication. Motion Dan Kuglin/Gary Anderson to approve agenda. All ayes. None opposed. Motion carried. Motion Dan Kuglin/Gary Anderson to approve minutes of the December 10, 2025 meeting minutes as published. All ayes. None opposed. Motion carried.

Treasurer's Report – Treasurer Wagner reads report. Motion Dan Kuglin/Gary Anderson to submit treasurer's report for audit. All ayes. None opposed. Motion carried. General Account: \$270,088.26; Recycling Account: \$2,767.92; Road Construction: \$179,817.61; Equipment Fund: \$30,934.00; Fire Equipment Fund: \$20,665.99; Revaluation Fund: \$90,000.00. Total Town Money: \$594,273.78. Tax Account: \$2,007,223.59.

Maintenance Supervisor Report – Two big storms to start the month, as well as ice. International is running okay. Two loads of salt and three loads of sand have been delivered so far. Two additional loads of sand have been ordered. Freightliner electrical issue has been fixed. John Deere tractor needs welding work on pins where bucket snaps on.

Public Appearances – None

Payment of Claims – Motion by Allan Weckwerth/Dan Kuglin to pay claims submitted for audit. All ayes. None opposed. Motion carried. General: \$64,011.53 Recycling: \$ 820.00

Chairman's Report and Correspondence – Five certified letters have been sent out by Dempsey Law Firm to property owners requesting that they correct right-of-way infractions. Two court cases have been filed. One has been dismissed. The other court matter had no response from the property owners on the summons and complaint. High power transmission line (275 mile line) has been approved and will be going through our town in 2026 and 2027. LRIP Reimbursement has been applied for on Oak Road. Internet connection recommendations will be put on February agenda.

Clerk's Report and Correspondence – There will not be an election in February.

Approve road project specs for 2026 – Chairman Weckwerth reads project specifications. Discussion held. Motion Dan Kuglin/Gary Anderson approve road project specs as presented for Old Green Lake Road. All ayes. None opposed. Motion carried. Project specs on file. This is a Town Road Improvement Project – Supplement (TRIP-S). TRIP-S funding is discussed. Pye Alley right-of-way project proposal read by Chairman Weckwerth. This work will be done by town, awaiting signature of property owner.

Dispose of Oshkosh Truck – Options of disposal of Oshkosh truck include: Possible trade for non-contract work will be considered, listing it for sale on Wisconsin Surplus or selling it for scrap. Discussion held. Motion Allan Weckwerth/Dan Kuglin to transfer ownership of Oshkosh Truck to Kopplin & Kinas in exchange for roadwork on Losinski Road to fix developing holes. All ayes. None opposed. Motion carried.

Update to Princeton Times (Berlin Journal) publishing policy – An email from Scott Mundro, editor, was received stating agendas and meeting minutes will no longer be published due to change in layout of paper if space is not available. Email was read by Chairman Weckwerth. The three official posting places for the Town of Princeton are: Town hall, Detjen's Piggly Wiggly and the town's website. The minutes and agenda will continue to be sent to paper every month, as they may still be published if space is available.
