**\*MINUTES**

**May 10, 2023**

Regular monthly meeting of the Board of Supervisors, Town of Princeton called to order at 7:00 pm by Chairman Weckwerth. Open meeting laws met through posting and publication. Motion Dan Kuglin/Gary Anderson to approve agenda. All ayes. None opposed. Motion carried. Motion Dan Kuglin/Gary Anderson to approve minutes of the April 18, 2023, regular meeting as posted. All ayes. None opposed. Motion carried.

Treasurer's Report – Treasurer Wagner gives report. Motion Dan Kuglin/Gary Anderson to approve treasurer's report and submit for audit. All ayes. None opposed. Motion carried.

Maintenance Supervisor Report – Chairman Weckwerth gives report. Storm water issues – need to remove three walnut trees on Lakeview and North Lawn in Terrace due to tile inlet in that location. Weckwerth spoke to Dornfeld about designing a storm water detention for water to settle out in salt before it gets to the lake. Estimated cost is \$10,500. This will not be covered by GLSD. Weckwerth is in the process of checking with the DNR for any possible grants that could cover this expense. \$460 was received from scrap yard for items taken there from the dump. Logging was done. Thirty logs were taken to New London, and almost \$700 was received from trees that were removed from right-of-ways. As of the meeting date, no equipment was on Bend Rd. to begin the project. Next road project(s) discussed. Oak Tree Acres cul de sac, which is in disrepair, is 18 feet wide and should be 20. Issues discussed on the following: Oak Rd, Fox River Dr, Elm Rd, Losinski, Roeder Rd, N. End of Losinski, Old Green Lake (spots), Otto Rd needs seal coat, Nelson Rd. Town should be due for TRIP money. East Court bid was \$30,000 last year (asphalt). Cost for road projects are \$250,000 per mile. There is a proposed new program for ag roads that there may be a grant available for. Due to the number of applicants, this may be a difficult grant to receive. Last year, \$82,000 was spent on road maintenance. GLSD is considering connecting Lill and Radke Rd in approximately five years. Road projects will be placed on future agenda.

Public Appearances – None.

Payment of Claims – Motion Dan Kuglin/Gary Anderson to pay claims as submitted. All ayes. None opposed. Motion carried.

Board of Review – Called to order by Chairman Weckwerth. Motion Dan Kuglin/Gary Anderson to elect Allan Weckwerth as chairman for 2023 Board of Review. All ayes. None opposed. Motion carried. Motion Dan Kuglin/Gary Anderson to elect Jill Bartol as clerk. All ayes. None opposed. Motion carried. Motion to appoint alternates of Becky Wagner, Chuck Grotzke and Rose Wick. All ayes. None opposed. Motion carried. Allan Weckwerth and Dan Kuglin have received their BOR training. Motion Dan Kuglin/Gary Anderson to adjourn Board of Review until open book on June 29, 2023, from 10:00 am to 12:00 pm by phone and BOR on July 12, 2023, from 5:00 pm to 7:00 pm. All ayes. None opposed. Motion carried.

Reilly's Pub Pier on Town Lot – Alyse Paulsen appears to request pier to be put on Town of Princeton lot. John Rypel, adjacent property owner, appears and objects. Discussion was held in regard to the length of the pier and the number of boats on pier. Rypel has furnished pictures showing more than two boats on pier and states people are walking on his property. Paulsen states Reilly's will do a better job of monitoring the pier, if necessary. Reilly's is receiving complaints from customers that the pier isn't long enough. Weckwerth states that the lake residents and public appreciate having Reilly's there. Discussion held. Motion Dan Kuglin/Gary

Anderson to allow Reilly's to put pier in according to DNR regulations. All ayes. None opposed. Motion carried.

UTV/ATV use on all Town of Princeton Roads – County is starting to post county roads. Most allow ATVs, only part of County Road D is allowed. No state roads allow ATV use.

Town Hall Ramp – Existing ramp is over 30 years old and is rotting. Dan Kuglin stated he received a complaint about the front steps. Front step quote received from Kuglin Construction for \$4,750. Weckwerth reads quote from Kuglin Construction to replace ramp with concrete base and metal handrails for \$6500. Weckwerth reads quote for replacing ramp with an aluminum ramp, total of \$3,650 (ramp) and \$2,000 (platform). A possible grant may be available for a portion of ramp replacement. Aluminum ramp has the possibility of salvage income when no longer in use, as a wood one would have no salvage value. Discussion held. The side door is also in need of replacement. Southside roof shingles are bad. Motion by Allan Weckwerth to hire Kuglin Construction to replace handicap ramp with all concrete ramp and metal handrails and accept bid for a total of \$6,500 from Kuglin Construction. Roll Call Vote: Chairman Weckwerth: Yes; Supervisor #1, Dan Kuglin, abstains; Supervisor #2, Gary Anderson: Yes. Motion carried by roll call vote.

Chairman's Report and Correspondence – Weiser Cemetery Committee held its annual meeting on May 2, 2023. The committee hired Nick Sina to provide lawn care for the cemetery. He will send an invoice at the end of the season.

Clerk's Report and Correspondence – None

Next Meeting Date – Fire District meeting to be held on June 7, 2023, at 7:00 pm. Next regular meeting date will be June 14, 2023, at 7:00 pm.

Adjourn – Motion to adjourn meeting by Dan Kuglin/Gary Anderson at 7:50 pm. All ayes. None opposed. Motion carried.
