Local Road Improvement Program applications – Town of Princeton should be in line for LRIP funds. Weckwerth explains programs and grants. Possible future road projects are: Oak Rd., Elm, Fox River Drive, East Court, Nelson Rd (north end), Kuharski Rd., Roeder Rd., Oak Tree Acres cul de sac, Oak Tree Court, Oak Tree Lane, Old Green Lake Rd. and stretch on Losinski Rd. Smaller maintenance projects also discussed. Applications due in November for programs. Motion Allan Weckwerth/Dan Kuglin to apply for TRIP program for Oak Road, Fox River Drive and Elm Street neighborhood of roads and to apply for TRIP-S and TRIP-D for Old Green Lake Road. All ayes. Ordinance will go into effect upon publication.

Motion carried. Motion Dan Kuglin/Gary Anderson to go back into open session at 7:48 pm. All ayes. None opposed. Motion carried. Brian Korth has been hired as maintenance supervisor. Employment to begin on November 1, 2023.
